# Introduction

The University of Cambridge has adopted the latest Model Publication Scheme produced by the Information Commissioner's Office (ICO). This Guide to Information has been prepared and is maintained in accordance with the ICO's latest Definition Document for Universities and other Higher Education Institutions. These template documents are available from the ICO website (https://ico.org.uk/).

This Guide was last updated in November 2021.

#### Layout

The Guide contains information grouped into the following seven categories, as delineated by the ICO:

Copies of requested datasets are published on the most appropriate pages of the University's website depending on their contents.

Information is not published in this Scheme: (i) where the University does not hold it; (ii) where the University considers it to be exempt under one of the exemptions in Part II of the Freedom of Information Act 2000; (iii) where it is archived, out-of-date, or otherwise inaccessible; or (iv) where the University considers that it would be impractical or resource-intensive to prepare the material for routine release.

Nearly all of the information is available from the University's website (https://www.cam.ac.uk). A few documents, notably the *Cambridge Pocket Diary*, are also published annually in hard copy and can be purchased at cost price from the Cambridge University Press Bookshop (<u>https://www.cambridge.org/about-us/visit-bookshop/</u>). Hardcopies of other publications are available as indicated on the website.

Most of the information contained in the Publication Scheme and listed in this Guide can be downloaded from the website free of charge. The University reserves the right to make a small charge for printed copies of some documents available on the website, to cover administrative costs.
